HOW WE WORK TOGETHER

DISMAS HOUSE

The CoreCivic Foundation was able to support Dismas House's health and wellness program that addresses mental health and substance use among returning citizens. Relapse is the cause of 95% of their residents not successfully completing the program. Our gift helped to provide 150 returning citizens with traumainformed mental health and relapse prevention programs.

MEN OF VALOR

The CoreCivic Foundation was able to support Men of Valor's operating costs. Men of Valor helps justice-involved men create a new life of hope, productivity and giving back. The services that Men of Valor provides is free to those in their program, so they rely entirely on donations from organizations like the CoreCivic Foundation.

THE NEXT DOOR



We know that victims of crime often suffer a broad range of psychological and social challenges that continue throughout their healing. CASA NASHVILLE

The CoreCivic Foundation was able to support CASA Nashville's Dual Status Youth Program with training curriculum and a full-time employee to lead this program. The program advocates for dual status youth (children with abuse/neglect issues and deliquency charges) who are involved in the Davidson County Juvenile Court System.


REFUGE CENTER FOR COUNSELING

The CoreCivic Foundation was able to support the Refuge Center for Counseling's reduced fees for clients. Though the average client fee per session was \$50, the actual cost was \$85. Our support helps the Refuge Center for Counseling's mission to offer affordable, professional counseling services in order to empower, educate and support individuals, couples and families in need.



TENNESSEE COALITION TO END DOMESTIC AND SEXUAL VIOLENCE

The CoreCivic Foundation was able to support the emergency financial assistance program at the Tennessee Coalition to End Domestic and Sexual Violence. This program provides moving and transportation costs for victims. Our support helps provide \$500 in emergency financial assistance to 85 low-income victims of domestic violence and sexual assault.

HOW WE WORK TOGETHER

BIG BROTHERS BIG SISTERS OF MIDDLE TENNESSEE

The CoreCivic Foundation was able to support Big Brothers Big Sisters of Middle Tennessee with targeted recruitment of children with incarcerated parents; mentor recruitment, screening and training; making compatible, lasting matches; setting goals; providing monthly case support; providing educational and recreational activities for matches; and administering outcomes assessments to measure impact.

BOYS AND GIRLS CLUB OF MIDDLE TENNESSEE

The CoreCivic Foundation was able to support the Boys and Girls Clubs' work to target underserved youth with programming and education in workforce development. These areas have been shown to significantly improve chances of academic success and on-time graduations.

PLAY LIKE A GIRL

The CoreCivic Foundation was able to support Play Like a Girl's virtual mentoring program. Designed to leverage sports to build a pipeline of young women in STEM, Play Like a Girl uses innovative approaches to students' learning needs with evidence-based practices that serve middle school girls in Nashville and across the United States.









WE COULDN'T DO IT ALONE

On October 7, 2021, CoreCivic held its 30th annual Charity Golf Classic. The tournament brought together approximately 270 individuals to raise support for 33 nonprofit organizations in Middle Tennessee that help support formerly incarcerated individuals, victims of crime and abuse, and youth. This event is made possible by the generous support of our business partners across the organization including law firms, financial institutions, suppliers, contractors, consultants and more.

Through the event, the CoreCivic Foundation raised \$565,000 in 2021, with more than \$7 million raised since the event's inception in 1991.

"This event has allowed us to serve the nonprofit community for 30 years now, and we are thrilled to have another opportunity to give back again this year," said Tony Grande, CoreCivic Foundation Chairman.



FUNDING ELIGIBILITY

Funding recommendations are made by the CoreCivic Foundation Advisory Committee and approved by our Foundation Board of Directors.

Grantees can be deemed eligible to receive funding through the CoreCivic Foundation by meeting a combination of the following criteria:

- Organization is a 501(c)(3)
- Aligns with CoreCivic's mission
- Supports offenders/former offenders, victims of crime and/or youth.
- History of relationship with CoreCivic through board service, volunteerism, etc.
- Must be willing and able to present measurable outcomes via an annual report or similar reporting measure
- Requested funds must be used for general operations and not in support of fundraisers or special events


